2	(i) Every tenderer/bidder must deposit a DD amounting to Rs. 10,000/- as	
	<b>EMD</b> to participate in tender auction. The tender will not be considered if	
	the earnest money is not deposited along with tender. Date of Demand	
	Draft should be drawn after the issue of the advertisement clearly indicated
