2	(i) Every tenderer/bidder must deposit a DD amounting to Rs. 10,000/- as EMD to participate in tender. The tender will not be considered if the earnest money is not deposited along with tender. Date of Demand Draft should be drawn after the issue of the advertisement clearly indicated in the form. (ii) The tenderer/bidder must deposit Rs. 100/- in the form of a separate DD as cost of tender form .
