1	Tender must be submitted in the prescribed tender form obtainable from the office of N.R.F.M.T.T.I., Tractor Nagar, Sirsa Road, Hisar (Haryana)-125001 on any working day (Monday to Friday) from <b>9 AM to 5 PM</b> from <b>11/05/2018 to 15/05/2018 (up to 1:00 PM on Tuesday)</b>
2	<p>(i) Every tenderer must deposit <b>Rs. 10,000/- as EMD</b> to participate in tender auction in shape of Cheque in favour of <b>The Director NRFMTTI, Hisar (Haryana)</b>. The tender will not be considered if the earnest money is not deposited along with tender.</p> <p>(ii) The tenderer/bidder should append his signature on the tender form, without which the bid is liable to be rejected.</p> <p style="text-align: center;"><b>The cost of tender form is Rs.100/- only.</b></p>
3	Tenderer may see/inspect the condition of the Wheat straw in any working days (Monday to Friday) between <b>9.00 AM to 5.00 PM</b> with the <b>permission of Farm In-charge/ nominated technical officer</b> by the concerned In-charge.
4	The tenderer should furnish his full name and address on the tender form.
5	Tenderer should submit tender form in a sealed cover, marked " <b>Tender for Purchase of Wheat straw</b> ". The tender will also be accepted by Registered Post before due date i.e. <b>15/05/2018 (01.00 PM)</b> . Institute will not be responsible for any postal delay or delay due to any reasons.
6	Last date and time for receipt of tender form is <b>15/05/2018 at 01:00 PM.</b>
7	Date and Time of opening of tender will be <b>15/05/2018 at 03:00 PM.</b> , in the Seminar Hall of NRFMTTI, Hisar - (Haryana) 125001.
8	<b>OPENING OF TENDER:</b> Bidders/tenderers are at liberty to be present himself/ themselves or authorize a representative to be present at the time of bid/opening of tender.
9	In case of Wheat straw, <b>50%</b> of bid amount has to be deposited by successful bidder on the spot and rest of <b>50%</b> of bid amount is to be paid e-payment on <b>NTRP (BHARATKOSH) Portal by 22/05/2018 or before start of lifting the wheat straw, whichever is earlier.</b>
10	It is to clarify that under any circumstances lifting of Wheat straw will not be allowed unless full amount of bid is deposited in the office. If the full amount of the bid is not deposit within stipulated time, all the deposited amount i.e. EMD and the amount deposit on the spot will <b>stand forfeited</b> and they <b>would be deposited</b> with the Govt. Account.
11	The successful bidder <b>should not sub-lease</b> the tender and in the event of this office coming to know about the sub-leasing of the tender, the entire amount shall stand forfeited.

14	EMD received from unsuccessful bidders will be returned immediately after the process of bid/auction is completed.
15	The Institute will not be responsible for any kind of theft / damage / losses to the tendered produce. However if any damage occurs to the properties of the institute by the bidder/tenderer or his representative or his labour, appropriate action will liable to be initiated against tenderer.

16	Lifting of Wheat straw will be allowed under the supervision of Farm In-charge/ supervisor during working days.
17	No child labour shall be engaged or caused to be engaged by bidder.
18	SECURITY DEPOSIT: A) For Wheat straw: Tenderer has to deposit 10% of the bid price as a security amount on the spot. B) The security deposit amount will be refundable after successful completion of tender period/tenure.
19	The Institute is under the provision of RTI Act 2005. All information provided by you under the act is liable to be disclosed.
