1	Tender must be submitted in the prescribed tender form downloaded from Institute's website: <a href="http://www.nrfmtti.gov.in">www.nrfmtti.gov.in</a> along with separate demand draft for EMD & cost of tender form in favour of <b>The Director, N.R.F.M.T &amp; T.I, Hisar, Haryana</b> , payable at <b>SBI, Main Branch, Code 0652, Hisar (Haryana)</b> .
2	<p>(i) Every tenderer/bidder must deposit a DD amounting to <b>Rs. 10,000/- as EMD</b> to participate in tender auction. The tender will not be considered if the earnest money is not deposited along with tender. Date of Demand Draft should be drawn after the issue of the advertisement clearly indicated in the form.</p> <p>(ii) The tenderer/bidder must deposit <b>Rs. 200/-</b> in the form of a separate DD <b>as cost of tender form</b>.</p> <p>(iii) The tenderer/bidder should append his signature on the tender form, without which the bid is liable to be rejected.</p>

9	The successful bidder is not permitted to sub-lease the tender and in the event of this office coming to know about the sub-leasing of the tender, the entire amount shall stand forfeited.
10	EMD received from unsuccessful bidders will be returned immediately after the process of bid/auction is completed.
11	The Institute will not be responsible for any kind of theft / damage / losses to the tenderer machine/equipment's/tools etc. used at site for work. However, if any damage occurs to the properties of the institute by the bidder/tenderer or his representative or his labour, appropriate action will liable to be initiated against tenderer.
12	No child labour shall be engaged or caused to be engaged by bidder.
