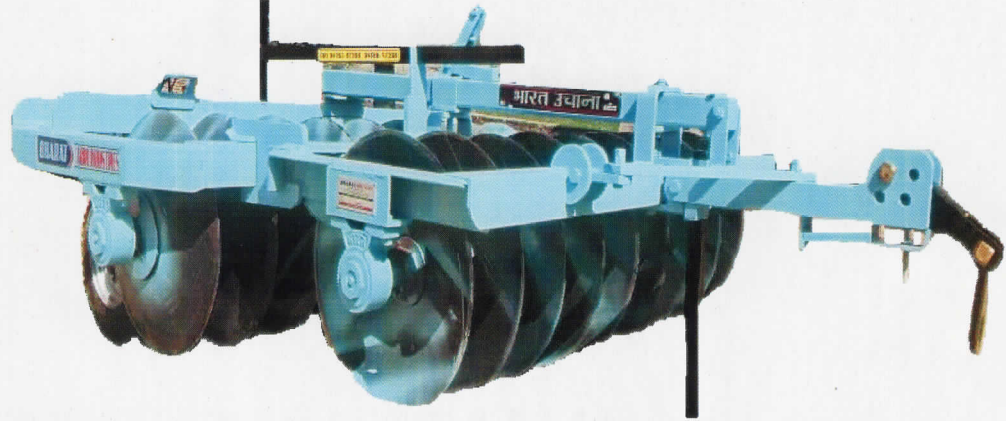

7. SUMMARY OF OBSERVATIONS, COMMENTS & RECOMMENDATION

- 7.1 The specification of disc harrow does not conform, in full, to the requirement of IS:6635-1972. This should be looked into for corrective action.
- 7.2 The specification of plain spool does not conform, in full, to the requirements of IS:7230-1974. This should be looked into for corrective action.
- 7.3 The specification for agricultural tillage disc does not conform, in full, to the requirements of IS:4366 (Pt-I)-1985. This should be looked into for corrective action.
- 7.4 The scrapers are welded to the frame and arrangement for adjustment is not made. It should be provided.
- 7.5 The chemical composition of disc does not meet in full, to the requirement of IS:9442-1980. This should be looked into for corrective action.
- 7.6 The labeling plate should be provided with following information
- Make
 - Model
 - Serial Number
 - Year of manufacture
 - Size of implement
 - Prime mover (Tractor) power requirement
 - Name of manufacturer
 - country of origin etc.
- 7.7 **Adequacy of literature**
No literature was supplied by the applicant for reference during testing.
It is recommended to provide :
 - Operator's manual
 - Service manual
 - Part's catalogue
The operator's manual should be developed and updated as per IS: 8132- 1999.
