### 6. SUMMARY OF OBSERVATION, COMMENTS AND RECOMMENDATIONS

- As per test report No. COMB-222/2640/2021, released in January, 2021, Clause/Para. No. 2.8(i) symbol No. 7.14, 7.15 and 7.27 among many more were not available. Now, applicant has provided the same on combine harvester as per IS: 6283 (Part1)-2006
- As per test report No. COMB-222/2640/2021, released in January, 2021, Clause/Para. No. 2.8(ii) symbol No. 8.5, 8.7 and 8.9 among many more were not available. Now, applicant has provided the same on combine harvester as per IS: 6283 (Part2)-2007
- As per test report No. COMB-222/2640/2021, released in January, 2021, Clause/Para. 20.4(i), slip clutch at cutting platform auger was not provided. Now, applicant has provided the same on combine harvester and conforms to the requirement of IS: 15806-2018.

- 6.4 As per test report No. COMB-222/2640/2021, released in January, 2021, Clause /Para. 20.5, grain tank was not provided. Now, applicant has provided the same on combine harvester and conforms to the requirement of IS: 15806-2018.
- 6.5 As per test report No. COMB-222/2640/2021, released in January, 2021, Clause/Para. 20.6, Fire extinguisher was not provided. Now, applicant has provided the same on combine harvester and conforms to the requirement of IS: 15806-2018.
- As per test report No. COMB-222/2640/2021, released in January, 2021, Clause/ Para. 20.10, labelling of control gauges and all operating controls did not conform, in toto, to the requirement of IS: 15806-2018. Now, applicant has provided the labelling of control gauges and all operating controls on combine harvester and conforms to the requirement of IS: 15806-2018.
- 6.7 The engine make model, power and specific fuel consumption is not specified on the labelling plate of the combine. The manufacturer address given in the specifications submitted and the labelling plate is different. It should be looked into for necessary corrective action.
- 6.8 The effect of the modifications on performance has been examined and considered that, the modifications are not going to affect the results of the original test. The Original test report, therefore, applies to the modified combine harvester also.
